province of Alberta, are providing to you documents of the April 9, 2024 petition of Dale J. Richardson, and the inhabitants of Colorado, signed by himself and the four other petitioners Tina Peters, Kaysha Richardson, John Sarina and Maureen Sarina. We are also providing the attached petition brief and the registered mail receipt of the documents that were submitted to Colorado Senator Mark Baisley for the Petition for Redress of Grievances. This was submitted to Senator Baisley by hand on April 9, 2024.
